

The Dolan Company Privacy Policy

(effective June 29th, 2011)

The Dolan Company and its subsidiaries (“DMC”, “we” or “us”) are committed to protecting the privacy interests of our consumers and are providing this privacy policy so that you know and understand how we will collect and use your name, email address, mailing address, telephone number, and/or credit number (all of which together we refer to as “Personal Data”).

This Privacy Policy applies to all Personal Data that we receive from (1) customers who provide us with Personal Data in connection with subscriptions to the print editions of our publications; and (2) customers when they visit, register or subscribe to the online editions of our publications as well as our related services or sites that link to this Privacy Policy.

We are not responsible for the privacy practices or the content on those sites. Information We Collect

We collect Personal Data about you when you subscribe to our publications, register to use our Web Sites, subscribe to certain subscriber-only portions of our Web Sites, use other products or services, visit our Web Sites, contact us about your subscription or participate in activities such as our blogs, forums, events, message boards, surveys and sweepstakes. How We Use Your Personal Data

4. To compile aggregate information about our customers, users of our Web Sites and usage patterns;
5. To measure the interest and popularity of stories and other features and services on our Web Sites; and
6. To enhance or develop features, products and services that we offer.

Occasionally, we may share your contact information (name and postal) with select partners or advertisers in order to provide valuable offers to you, unless you have expressly requested us not to do so. Cookies

As is standard industry practice, we use “cookies” and other technologies to recognize you and help us understand areas of our Web Sites that interest our customers and how long they visit those areas. We also use “cookies” to facilitate the login process for our email alerts and archives, deliver advertisements to you, determine traffic and to help us improve our Web Sites.

You can set the browser on your computer to warn you each time a cookie is being sent, block third party cookies or block all cookies. However, you may not be able to access certain features of our Web sites if you have blocked all cookies on your computer.
